## EXECUTIVE SUMMARY

This document is deliverable “D7.4 – Second revision of Data Management Plan (DMP)” of the European Union project “Retrofitting towards climate neutrality” (herein referred to as “**Green Marine**”), with **grant agreement No. 101096522**.

The **Green Marine** Second revision of the Data Management Plan (DMP) reiterates the specific section in the deliverable “D7.3 Initial Data Management Plan (DMP)”. Note that CMMI, UPM, SINTEF, and UoS have confirmed no changes as reported in the Initial Data Management Plan (DMP). SMP/WPS, BX, CalMac, and PDM suggested some adjustments (i.e., inclusion/ removal of data sets), thus a table was added in the report to monitor such modifications. Also, note that the draft DMP was included in section 6 of the D7.2 Project Handbook including draft Data Management Plan.

This deliverable mainly targets the consortium partners as this revised data management plan defines the purpose and scope of the DMP, the FAIR data principles (findability, accessibility, interoperability and reuse), the research outputs, allocation of resources, data security and ethics.
